We are a community owned not-for-profit organization that includes Scotland Memorial Hospital, Scotland Regional Hospice, Scotland Memorial Foundation, Scotland Physicians Network and Scotland Family Counseling Center.

Our management agreement with Atrium Health supports our independence, offering tremendous talents and resources in order for Scotland Health Care System to continue to provide our community members high quality services focused on individual patient needs.

**Our Mission:** The Mission of Scotland Health Care System is to work with our health care partners to create and operate a patient centered, integrated system to provide Safe, High Quality, Compassionate, and Sustainable health care to the people we serve.

**Our Vision:** Scotland Health Care System will be recognized and chosen by patients and their families throughout our region for the quality and value of services we provide. This value will be demonstrated through the highest level of quality and service, along with the safest environment. We will lead efforts to improve the health and well-being of the citizens in our region.

**Our Values:** We accept and are proud of our role as the safety net provider of essential services for our region.

- As a community owned health care system, we believe in transparency and accountability to our community for the decisions we make. These decisions will be made collaboratively and with the utmost integrity.
- Our associates, physicians, other providers, and volunteers are our most important assets. We treat each other, along with our patients and families, with care, compassion, dignity and respect at all times.
- We carry out all these principles in a financially prudent and sustainable manner to ensure we stay focused on our Mission.

Scotland Memorial Hospital started in 1946 in the medical facilities of the deactivated Laurinburg/Maxton Air Base. In 1951, it moved to McLean Street as a 100-bed facility and, with additions in 1956 and 1965, increased the number of its acute care beds to 124. In 1983, the hospital opened its new facility on its current campus and is licensed for 104 acute care beds.

Scotland Health Care System offers a full range of acute care and outpatient care services.

- A staff of over **1,000 full-time and part-time employees** makes us the area's largest private employer.
- Our providers cover a wide range of specialties from: anesthesiology to vascular surgery.
- **Scotland Health Care System** owns and operates the following:
  - Three Ob/Gyn practices – one in Scotland County, one in Robeson County, and one in Marlboro County.
  - Two surgical practices – one in Scotland County and one in Marlboro County.
  - An ENT practice located in Laurinburg.
  - Six primary care practices – two located in Laurinburg and the outlying regions of Wagram, Maxton, and Pembroke in North Carolina; and Bennettsville in South Carolina.
  - Scotland Endoscopy Center, an outpatient endoscopy center in Laurinburg, where convenient screening colonoscopies are provided.
  - A Nephrology practice located in Laurinburg.
  - A Pulmonology Practice located in Laurinburg
- We treat an average of 55 inpatients daily and perform over 6,000 surgeries annually.
- Approximately 55,000 patients are seen in our Emergency Center each year.
- Close to 700 babies are delivered at Scotland Memorial Hospital each year.
- **Scotland Health Care System** operates two urgent care facilities which provide patients with non-emergent health care needs, shorter wait times and often lower costs than a visit to the Emergency Center. No appointments are necessary.
  - **Scotland Urgent Care and Occupational Health Services** is located on the hospital campus in the Community Health and Rehabilitation Center. It is open seven days a week from 8:00 am to 6:30 pm.
- **Marlboro Family Practice and Urgent Care is located in the Marlboro Medical Complex.** Urgent Care services are provided Monday through Thursday from 7:00 am to 6:00 pm , Fridays from 8:00 am to 5:00 pm., and Saturday from 8:00 am to 1:30 pm.

- **Outpatient Imaging Center**, conveniently located on the corner of the hospital campus, offering outpatient imaging services for 3D mammograms and ultrasounds of the breast.
- **Sophisticated technologies include:** open-bore MRI, nuclear medicine, CT scanning with a state-of-the-art 64 slice CT scanner, laser surgery, PET scans, and 3D mammography.
- **Scotland Mobile Health Care** provides mobile health care services to our community and industries.
- A successful **Cardiopulmonary Rehabilitation Program** enhances the health of patients with heart disease or certain breathing problems or diseases.
- **Scotland Cancer Treatment Center** provides quality medical and radiation oncology services through its affiliation with Duke Health. All of the Center's medical providers are Duke-affiliated with access to many of Duke's resources.

Our cancer center offers the latest in linear accelerator technology with intensity modulated radiation therapy (IMRT), multi-leaf collimation (MLC), electronic portal imaging, and image-guided radiation therapy (IGRT) capabilities.

- **Scotland Regional Hospice** is a non-profit Medicare and Medicaid certified health care provider licensed by the State of North Carolina and accredited by the Accreditation Commission for Health Care Inc. Scotland Regional Hospice has been addressing the special needs of families facing end-of-life issues since 1986.
- The seven-bed **Center for Inpatient Rehabilitation at Scotland Memorial**, on the third floor of the hospital, offers a specialized program for hospitalized patients problems.
- **Scotland Sleep Center** is a four-bed facility which provides access and timely results and treatment for those suffering with sleep disorders. Patients spend one night in the Sleep Center's private room for a simple, painless procedure where brain waves, muscle activity, leg movements, heart rhythms, and other body functions are monitored while they sleep.
- **Scotland Cardiovascular Center**, a joint venture with FirstHealth of the Carolinas, is a state-of-the-art facility providing cardiac catheterizations and urgent and elective percutaneous coronary intervention services for heart disease and vascular procedures to treat circulation problems. Scotland Cardiovascular Center allows our patients to enjoy the type of care found at a major medical facility combined with the comfort and convenience that comes from being close to home.

- **Scotland Family Counseling Center** Scotland Family Counseling Center provides outpatient mental health services to a five-county area. This private, non-profit corporation is dedicated to providing faith-integrated professional counseling services to individuals, couples, families, and children.
- **Marlboro Medical Complex**, housing Scotland Pharmacy - Marlboro and Marlboro Family Practice and Urgent Care.
- **Marlboro Specialty Center**, a new state-of-the-art facility for Marlboro Surgical Associates, OrthoCarolina Scotland, and Women's Health Center of the Carolinas Marlboro.
- **Retail Pharmacies** conveniently located inside of Harris Family Practice, Marlboro Family Practice and Urgent Care and Pembroke Family Practice
- **Emergency Air Medical Transportation Service**, a partnership with Cape Fear LifeLink Air to station a helicopter 24/7 on the Scotland Memorial Hospital campus to cut response times and deliver critical care air ambulance services to patients following a traumatic illness or injury.

- **The Scotland Wound Healing Center** is specifically designed to treat patients with hard-to-heal sores or wounds, often utilizing the two hyperbaric oxygen chambers. The Center is located in the Community Health and Rehabilitation Center. Inpatient wound care is also provided.
- **The Outpatient Rehabilitation Services Department** includes a rehabilitation gym and private treatment rooms designed for one on one treatments and evaluations. Services include Occupational Therapy, Physical Therapy, Recreational Therapy, and Speech Therapy.
- The newly renovated **Scotland Women's Center** consists of Labor and Delivery, Obstetrics and Gynecology rooms, and a Nursery. The staff of the Women's Center is dedicated to providing you and your family members with the information and education needed to make informed decisions throughout the childbearing years.

## MEDICAL SPECIALISTS

---

**Advance Practice Providers (APP)** – medical professionals who have received Advance Clinical education and skills.

**Allergist** – a physician who examines, diagnoses and treats allergic disorders.

**Anesthesiologist** – a physician specifically trained to induce the partial or complete loss of consciousness by the administration of a drug or gas.

**Cardiologist** – a physician who specializes in the study of the heart's actions and diseases.

**Certified Nurse Midwife (CNM)** – a registered nurse with advanced training who provides care for women across their lifespan including minor gynecologic problems and the care of mothers and babies throughout the maternity cycle, including postpartum.

**Certified Registered Nurse Anesthetist (CRNA)** – advanced practice registered nurse with specialized, graduate-level education in anesthesiology.

**Dermatologist** – a physician who specializes in treating diseases of the skin.

**Emergency Medicine Physician** – a physician specifically trained in the treatment of persons requiring immediate care.

**Family Nurse Practitioner (FNP)** – a registered nurse with advanced preparation in the care of pediatric and adult patients who provides primary care in conjunction with a collaborating physician.

**Family Medicine Physician** – a physician who offers general, comprehensive medical care for the entire family.

**Gastroenterologist** – a physician concerned with the study of the physiology and pathology of the stomach, intestines, and related structures such as the esophagus, liver, gallbladder, and pancreas.

**General Surgeon** – a physician who specializes in performing operative procedures for the correction of deformities and defects, the repair of injuries, the diagnosis and cure of diseases, and the relief of suffering.

**Gynecologist** – a physician who specializes in the diseases and hygiene of women.

**Hematologist** – a physician who specializes in the diagnosis and treatment of blood disorders.

**Hospitalist** – a physician who specializes in caring for patients in the hospital.

**Internal Medicine Physician** – a physician who focuses on adult medicine and has had special study and training focusing on the prevention and treatment of adult diseases.

**Laborist** – an obstetrician/gynecologist who works full-time in a hospital delivering babies. A laborist does not see patients in an office setting, as a traditional obstetrician/gynecologist does.

**Medical Oncologist** – a physician who specializes in the branch of medicine dealing with tumors.

**Nephrologist** – a physician who specializes in the study of the structure, functions and diseases of the kidneys.

**Neurologist** – a physician who specializes in diseases of the nervous system.

**Obstetrician** – a physician who specializes in the treatment of women during pregnancy and the birth process.

**Occupational Medicine Physician** – a physician who specializes in industrial health care services, including medical management, injury care, rehabilitation, safety and training.

**Ophthalmologist** – a physician who specializes in the treatment of disorders of the eye.

**Orthopedic Surgeon** – a physician who specializes in surgical prevention and correction of deformities or disorders involving those structures which the body uses in movement.

**Otolaryngologist** – a physician who specializes in the study of diseases of the ear, nose, and throat.

**Pathologist** – a physician who interprets and diagnoses the changes caused by disease in tissues and body fluids.

**Pediatrician** – a physician who specializes in the development, care and diseases of children.

**Physiatrist** – a rehabilitation physician who treats any disability resulting from disease or injury, from sore shoulders to spinal cord injuries.

**Physician Assistant** – a specially trained and licensed individual who provides primary care for pediatric and adult patients under the direction of a supervising physician.

**Pulmonologist** – a physician concerned with the anatomy, physiology and pathology of the lungs.

**Radiation Oncologist** – a physician who uses ionizing radiation in the treatment of cancer.

**Radiologist** – a physician who specializes in the use of x-ray energy for diagnostic and therapeutic purposes and also interprets studies using ultrasound, nuclear medicine and magnetic resonance imaging.

**Urologist** – a physician who specializes in the function and diseases of the urinary tract in both sexes and the genital tract in the male.

**Vascular Surgeon** – a physician who specializes in the diagnosis and treatment of diseases affecting the circulatory system, excluding the heart.
