The Pediatric Infectious Diseases physicians <u>must</u> be called on <u>all</u> restricted antimicrobials Pediatric infectious disease delegates are on call from 7am-11pm. If an order is received outside the on-call hours, pharmacy will process the order and notify pediatric infectious disease for follow-up next day. These restrictions apply to a) all patients on Pediatric Units and b) all patients < 12 years old on other units. When used in pediatric patients the following antimicrobials require approval by a member of the Pediatric Infectious Diseases Service.

When used in pediatric patients the following antimicrobials require approval by a member of the Pediatric Infectious Diseases Service.
