

Undergraduate Transfer Student Awards Terms and Conditions

Transfer Student Awards

Awarded to new undergraduate transfer students who attended one or more U.S. regionally accredited institutions of higher education. Some scholarships require attendance at a North Carolina Community College.

The North Carolina Community College (NCCC) Partners Scholarship:

Need-based institutional aid award for new undergraduate transfer students who enroll full-time directly from Central Piedmont Community College, Rowan-Cabarrus Community College, or Stanly Community College who exhibit financial need of Tuition and General fees less Expected Family Contribution (EFC) and estimated Financial Assistance as determined by the FAFSA. New students are automatically reviewed and considered for this award.

- 1. The NCCC Partners Scholarship is offered to a new undergraduate transfer students who:
 - a. Transfer directly from Central Piedmont Community College, Rowan-Cabarrus Community College, or Stanly Community College; and
 - b. Has a Community College cumulative GPA of 3.0 from the last Partner Institution attended; and
 - c. Enrolls full-time (12 credit hours or more).
- 2. The scholarship does not require a separate scholarship application. To apply, submit a:
 - a. Completed application for admission; and the
 - b. Free Application for Federal Student Aid (FAFSA) at <u>fafsa.gov</u> (use Cabarrus College code 015358).

The NCCC Allied Health Transfer Scholarship:

- 1. The NCCC Allied Health Transfer Scholarship is offered to new undergraduate transfer students who:
 - a. Transfer directly from an accredited North Carolina Community College; and
 - b. Have a Community College cumulative GPA of 3.0 from the last North Carolina Community College attended; and
 - c. Enroll full-time in one of the following Allied Health baccalaureate degree programs: Biomedical Sciences, Community Health & Wellness, Health Sciences Leadership and Development, Medical Imaging or Respiratory Therapy.
- 2. The scholarship does not require a separate scholarship application. To apply, submit:
 - a. *Completed* application for admission; and
 - b. Official North Carolina Community College transcript; and the
 - c. Free Application for Federal Student Aid (FAFSA) at <u>fafsa.gov</u> (use Cabarrus College code 015358).
- 3. The scholarship is stackable (e.g., may be used in conjunction with other scholarships/awards)
- 4. The maximum award amount is \$1500 maximum/academic year.

The NCCC Nursing Transfer Scholarship:

- 1. The NCCC Transfer Scholarship is offered to new undergraduate transfer students who:
 - a. Transfer directly from an accredited North Carolina Community College; and
 - b. Have a Community College cumulative GPA of 3.0 from the last North Carolina Community College attended; and
 - c. Enroll full-time in one of the following Nursing baccalaureate degree programs: RN-BSN or 4-year BSN.
- 2. The scholarship does not require a separate scholarship application. To apply, submit:
 - a. Completed application for admission; and
 - b. Official North Carolina Community College transcript; and the
 - c. Free Application for Federal Student Aid (FAFSA) at <u>fafsa.gov</u> (use Cabarrus College code 015358).
- 3. The scholarship is stackable (e.g., may be used in conjunction with other scholarships/awards)
- 4. The maximum award amount is \$1500 maximum/academic year.

The Phi Theta Kappa Transfer Scholarship:

- 1. The Phi Theta Kappa Transfer Scholarship is offered to new undergraduate transfer students who: a. Have been inducted into the Phi Theta Kappa National Honor Society
- 2. The scholarship does not require a separate scholarship application. To apply, submit:
 - a. Proof of membership into Phi Theta Kappa to the Office of Financial Aid; and the
 - b. Free Application for Federal Student Aid (FAFSA) at <u>fafsa.gov</u> (use Cabarrus College code 015358).
- 3. The scholarship is stackable (e.g., may be used in conjunction with other scholarships/awards)
- 4. The maximum award amount is \$1000 maximum/academic year.

The Transfer Student Legacy Scholarship:

- The Alumni Legacy Scholarship is offered to new undergraduate transfer students who:
 a. Are dependents (as determined by the FAFSA) of a previous Cabarrus College graduate.
- 2. The scholarship does not require a separate scholarship application. To apply, submit:
 - a. Proof of affiliation by providing the alumna name, degree, and year of graduation to the Office of Financial Aid; and the
 - b. Free Application for Federal Student Aid (FAFSA) at <u>fafsa.gov</u> (use Cabarrus College code 015358
- 3. The scholarship is stackable (e.g., may be used in conjunction with other scholarships/awards)
- 4. The maximum award amount is \$500 maximum/academic year.

Atrium Health Teammate Dependent Scholarship

Institutional aid award for new students who enroll full-time. New students are automatically reviewed and considered for this award.

- 1. The Atrium Health Teammate Dependent Scholarship is offered to a new, full-time student who is:
 - a. Newly admitted to Cabarrus College of Health Sciences; and
 - b. Pursuing a first degree (not a second degree); and
 - c. A dependent student as determined by the FAFSA; and
 - d. Whose parent/guardian is currently employed by Atrium Health.
- 2. The scholarship does not require a separate scholarship application. To apply, submit a:
 - a. Completed application for admission; and
 - b. Completed Employment Verification Form; and the
 - c. Free Application for Federal Student Aid (FAFSA) at <u>fafsa.gov</u> (use Cabarrus College code 015358).
- 3. The scholarship is stackable (e.g., may be used in conjunction with other scholarships/awards)
- 4. The maximum award amount is \$1000/academic year.

Terms & Conditions for Transfer Students

- 1. To be eligible, students must complete the FAFSA and submit all required documentation.
- 2. The student must not be in default on any Federal student loan.
- 3. The student must be a United States citizen or eligible non-citizen to qualify for all scholarships, awards and tuition discounts, with the exception of the Atrium Health Loan Forgiveness program.
- 4. The College will notify students if they qualify. The scholarship will be included on the student's financial aid award notification letter. Upon enrollment, scholarship awards are administered by the Office of Financial Aid.
- 5. The Scholarships are renewable for the maximum during as defined below, starting with the first semester the award isscheduled to begin, not to exceed eight (8) consecutive semesters total or the completion of a baccalaureate degree, whichever comes first. In the case of the NCCC Partners Award, this award may be replaced with other forms of Institutional Aid in future years (after the first award year).
- 6. The maximum duration of this scholarship is established by the number of transferable credit hours determined after all official transcripts have been received. Courses in progress during the application process must be completed before enrollment.

- 7. Upon enrollment, the scholarship is applicable to the fall and spring semesters, not the summer term. The yearly award will be divided among the semesters and applied to the student's bill each semester of full-time enrollment to pay for full-time tuition.
- 8. The scholarship recipient must maintain satisfactory academic progress, good social standing, and continuous enrollment each semester.
- 9. If an Atrium Health Teammate is discharged or leaves their position within Atrium Health, the scholarship will be voided or adjusted.
- 10. If a student must withdraw during the semester and tuition is partially refunded, the scholarship will also be adjusted.
- 11. The NCCC Partners Scholarship is based on tuition and general fees less Expected Family Contribution and other federal and state need-based grants, and other financial assistance. Consequently, scholarships and awards may be reduced, adjusted, or rescinded if the student's financial need changes due to receipt of other grants, scholarships or benefits restricted to tuition from outside agencies or third-party entities, or if a student's total federal, state, and other institutional awards would exceed the tuition and general fees less the EFC and other financial assistance.

The award will be calculated as such:

Step 1: Direct Costs (tuition + general fees) - Expected Family Contribution = **Need** Step 2: Need – Federal Grants – State Scholarships = **Unmet Need**

Step 3: Unmet Need will be covered by institutional aid dollars including Lettie Pate Whitehead, 1942 Club, Merit Scholarship and Endowed Scholarships, and any remaining balance (for Direct Costs) will be covered by the **NCCC Partners Scholarship** (amount varies).

- 12. The scholarship offer must be accepted by the deadline or funds may expire or be offered to other students. Late Admissions applications may not receive full consideration, regardless of eligibility.
- 13. If a student needs to defer admission/enrollment to a future semester, decisions on (1) admission,
 (2) scholarship and (3) need-based financial aid are not automatically approved for the new term that is, eligibility/offers may change from year to year.
